Gold Hill Lutheran Church Annual Meeting – January 26, 2020

The annual meeting of Gold Hill Lutheran Church was called to order by Michael Lawson, President. He welcomed everyone and thanked them for attending. He also thanked all who provided food, set up and cleaned up for the potluck meal we enjoyed.

Pastor Trina Johnsten led the fifty-one voting members and numerous guests in prayer.

Heatherlynn Meeks moved, Dorothy Anne Honeychurch seconded the approval of the minutes from last year's annual meeting. The motion passed.

President's Report: The report of the President is found on page 9 of the Annual Report. Mike emphasized that this year was a year of transition. He stated that the council members worked together to take care of all issues that came before them. He feels we will "continue on as a family in Christ".

Pastor's Report: Pastor Trina had no additional comments. Her report is found on page 6 of the Annual Report.

Financial Report: Revonda Stordahl reported that the income for 2019 was less than budgeted, but that expenses were also less than budgeted. We ended the physical year with a surplus of \$26,000.00. We had budgeted sending 8% of our offering to the Montana Synod, though we wanted to send 10%. Because of the surplus we were able to send the 10% to the Montana Synod. There were no questions on her report.

New Business: Curt Quist asked for Mike to explain the work that had been completed on the Membership Lists for Gold Hill. Mike explained that Pastor Trina provided a letter that she had used previously with other congregations, and we found it very compassionate and understanding in reference to whether individuals wanted to remain members of Gold Hill, had moved, or wanted to be removed from our church roster. The letter was sent to individuals who had not attended a church service recently, had not received communion, or/and had not given to the church financially. We had no complaints from recipients. The office received letters from members asking to remain on the roster, asking for letters of transfer to other churches, or asking to be removed. We removed 133 members from our roster and transferred 3 members. We had approximately 10 individuals who at this time wished to remain on our roster and will be retained as associate members. Pastor Trina explained that an associate member was a member who we, the church, cared about and took care of when needed, but that the member does not have a vote and cannot hold an office on the church council.

Jeanette Nielsen reported that there are about 42 members who provide help in the form of providing food and/or helping in the kitchen during funerals. If anyone would like to help and has not been contacted, please let her know.

Old Business: Ron Gruss reported that the Trust Review Committee, created two years ago, has been meeting to streamline, review the purpose of the trust and trying to find a way to get money out to where it needs to go quicker. The committee will be meeting on January 27th at the church. He also commented that on page 21 the report for the Trust Committee should state for the year 2019-2020. It is printed incorrectly.

Dale Schultz reported that the Call Committee is moving along. When asked if there was a candidate, he said he cannot say.

Elections: Bob Brown announced that there are changes to the printed report and that Susan Stamp the chairman was unable to be at the meeting. Cheryl Neuhart added that under Outreach Ministry Dale Schultz is willing to serve and that Bob Brown will replace Bruce Graving as Flathead Bible Camp Representative. Heatherlynn Meeks moved, and Dorothy Tallon seconded that we accept the slate of officers as presented by the nominating committee. The motion passed.

The following were elected: Curt Quist for a two-year term as Administration Director; Peggy Graving to a two-year term as Secretary; Lynn Aniksdal for a two-year term as Leadership Minister; Dale Schultz for a two-year term as Outreach Minister; Mike Welker to a five-year term on the Trust Committee; Ginger DeWitt to a three-year term on the Audit Committee; and Bob Brown and Julie Corbin to one-year terms as Flathead Lutheran Bible Camp representatives. Jerry Aaker, Mark Bond, Ann Drew, Peggy Probasco, Nancy Rowe, and Ken Stamp were elected as the nominating committee for one year. Our delegates to the 2020 Montana Synod Assembly are Mike and Annette Lawson.

Proposed Budget: Revonda directed us to pages 28-29 – right hand column to look at the proposed budget for 2020. We budgeted for less income and less in expenses hoping that we can meet this goal next year. The budget has a deficit of \$10,950, but the council is comfortable with this due to the surplus from last year. We have budgeted the full 10% to the MT Synod.

Bob Brown stated that it does not take long when you have a full time Pastor and have to pay their insurance and their retirement through Portico to go through a surplus like we have. We should not feel or have the "illusion" that we are rich because we have a surplus. It is unusual for us to have a surplus and when we have a full-time pastor, things could change quickly.

Curt Quist moved, Marshal Cook seconded and it was approved to accept the budget for 2020. Bob Brown thanked Jerry Aaker for serving as the Outreach Minister for the past two years. The meeting was closed following the Lord's Prayer led by Pastor Trina Johnsten.

Special Congregational Meeting of Gold Hill Lutheran Church March 15, 2020

Curt called the special meeting of the congregation to order following Sunday Service on March 15, 2020. The purpose and only business before the congregation is the vote to Call a new Pastor. Curt called on Dale Schultz, the chairman of the Call Committee. To verify the presence of at least fifty members of the congregation Dale took photos of those present. This was in lieu of passing around paper and pencil since we are trying to social distance ourselves due to the COVID- 19 virus. There are fifty-nine voting members of Gold Hill present.

Dale reported that the call committee reviewed, interviewed by video and in person the Reverend Marlow Carrels. The committee moved and seconded we, the members of Gold Hill call Reverend Marlow Carrels to serve as our Pastor. Discussion included a short biographical presentation of Pastor Carrels. He is currently serving at St. John's Lutheran Church in Westby, Montana. He is married to Nikki, and they have one daughter. He has a Bachelor of Arts degree in literature from MSU and received his theology degree in 2017. He served in the Army for eleven years in different capacities. Dale shared that his strengths include administration, worship, teaching, arts, and music. He likes to plan and set goals. He likes to empower the leaders of the congregation. His wife is a teacher, and they would likely not come until the first of June. They would like to live in the parsonage.

The vote was called, and it was unanimous to Call Pastor Marlow Carrels to Gold Hill Lutheran Church.

Kay Vang moved; Jon Williamson seconded that the meeting be adjourned. The motion carried and the meeting was adjourned.

Goals for the Year:

- 1) Reopen Church in a safe manner for all people: There is renewed fervor in reopening the state as soon as possible now that a vaccine is available for Covid. While I understand that there is a vaccine the rollout plan is still coming together, and it will take time and patience to be able to come back together. Just because businesses and restaurants are reopening does not mean that the church building should reopen. They are of the world; we are of God and should do all things toward love for our neighbor.
- 2) Create our streaming platform that will be used in perpetuity: We as a congregation are reaching a larger number of people due to our current streaming of service over the internet. We have received a grant from the synod and gifts from members and non-members to keep this ministry going. As such we will need a few "techy" volunteers to help with this transition.
- 3) Create opportunities to learn about stewardship: Often we think of stewardship as \$\$\$ only. What are your talents? How do we use them in this congregation? How do you give? Have we spoken about end of life giving? Service to the church? Janitorial help? Counters? Singers? Ushers? Sewers? Cooking? Community outreach with the Homeless Uptown or BRM? Working with the pre-release program? How can our congregation give unlimited ways for you serve this congregation and others that involve all our talents and our money?

THE BIG PICTURE

"For as in one body we have many members, and not all the members have the same function, so we, who are many, are one body in Christ, and individually we are members one of another. We have gifts that differ according to the grace given to us..." (Rom 12:4-6 NRSV)

Sisters and Brothers in Christ may the God who grants us gifts bring you peace in this new year. You, as a congregation, called me to this place to use my gifts in leading this parish toward your goals. You want to work with our sister church in the Flats. You have looked to reopening slowly and meaningfully in this strange year! You are meeting the future boldly. Over this next year we will work more deftly with Gloria Dei, and as our sense of normalcy grows, we will join them in our endeavors to serve God.

Serve the world, especially the poor and those in need: You have given grandly to our community. You continue to support the Food Bank, LWR, and our Synod, supported battered women, the Furniture Bank, and given much needed dignity to women in our local rescue mission. Over the next year we will get our Stephen Ministry back "up to snuff" along with a Visitation Working Group that will take church out of these walls and deliver time and communion to members of our community who are home and hospital bound. These individuals will take with them a spirit of grace and kindness to God's beloved and bring their stories back to the congregations.

2020 Council President's Annual Report

Greetings to you all, members of Gold Hill Lutheran Church.

As I write this report, two weeks before Christmas, and look back at this year of 2020, it's been one of the most challenging years in any of our lives. The Covid-19 Pandemic has turned this country, this state, this city of Butte and our Gold Hill Lutheran Church upside down. We haven't worshiped in our Sanctuary since March 15th when we voted to call Marlow Carrels to be our new Pastor. We have had to wear masks, social distance and not gather in groups or crowds. We have adapted, under the leadership of Pastor Carrels and the Church Council, to find alternative ways to worship and keep in contact (thinking outside the box). In spite of that, a number of our members have come down with the Covid virus and as one of them told me "I wouldn't wish this on anybody". Yes, we pray for them and for each other, both personally and as a church. The most comforting thing of hope is knowing our Lord is with us, has His arms around us, walks with us and carries us when we need to be carried. That's why we're still a church, who loves the Lord and from that love we can love and care for each other.

This year started out as a fairly normal year with our worship services being conducted by interim Pastor Trina Johnsten, guest Pastors, and Gold Hill Lutheran Church lay leaders and ministers. We had our Executive/Church Council meetings as well as different Church committee meetings. The Choir practiced and sang, and the Quilting and Shawl ladies continued to make their beautiful quilts and shawls. Many of these things had to stop or be limited with the Covid-19 pandemic. The County Health Department issued new rules/guidelines, as an attempt to keep people safe from getting this virus or giving it to others. Our Council's main concern here at Gold Hill has been the prevention of anyone getting this terrible virus and complying with the Silver Bow County Health Department directives. The Council had to close the Church and Sanctuary to Worship and visitation, except for essential personnel. We as a Council met through Zoom on our computers. Our Worship Services were in the Parking-Lot. YouTube streaming services became available for your weekly worship. Pastor Marlow has a Bible Study on Wednesday night and a Men's Bible Study on Thursday morning on Facebook. He is also doing a Wednesday Devotion on Facebook. Mary is in the office on Monday and Friday and working from home during the rest of the week.

This has been a good year in that Pastor Marlow Carrels became our new pastor. He was interviewed by phone, by our Call Committee, came for an in-person interview in February, was voted on to be called by the Congregation in March, moved to Butte in May, and officially became our Pastor on the first of June. He's been instrumental in the creation and carrying out of our Worship format services, as well as doing the many facets of ministry it takes to be our Pastor at Gold Hill. He, his wife Nikki, daughter Sammie (and a new baby-to-be-born in June) love Butte. They are living in our parsonage along with a few egg-laying chickens. Pastor Marlow is a veteran and a well-received Pastoral Leader, especially with all he's done here at Gold Hill in this Covid-19 time. He's anxious to meet all of you personally and welcomes your calls.

The Gold Hill Council continues to work on solutions for bringing us to worship and to keep us connected in a closer way. We welcome your calls to us and we're going to get back to calling each of you on a regular basis, to just say hi and see how you're doing. Just know each of you are a brother or sister in our Gold Hill Lutheran Church family and we deeply care about you. May 2021 be a year of recovery and healing which will bring us back into our Church Sanctuary for worship. In the meantime, come to worship through FaceTime, YouTube, or come to our Sunday morning Parking Lot Church Service, at 9:30 am.

May God Bless each and every one of you.

Annual Report 2020 from the Administration Director

In 2020 the Church Council adopted a Parsonage Use Policy, a Debit/Credit Card Policy, and Fellowship Hall and Room Rental Policies in tandem to our Building Use Policy. We are slowly adopting policies to protect our congregation from criticisms and possible litigation from not having defined policies in place.

The Trust Review Committee was formed, met, and brought back recommendations to the Church Council.

Gold Hill Church Council and Gloria Dei Church Council met together for an evening social time, and we discussed how we can work together to accomplish our shared ministries. During the pandemic, most of the suggestions have been put on hold until we can get together again.

The Church Council worked with the pre-school on their re-opening plan. We talked about how it would impact the church and how they could mitigate as much exposure to us as possible. They would have to go through Butte-Silver Bow Health Department for their own re-opening plan separately from Gold Hill Lutheran Church.

We call for volunteers to serve on a committee to assess possible uses for our vacant lot to the northeast of the church. These findings/suggestions would be brought to an annual meeting for discussion.

The biggest accomplishment of the 2020 Church Council was the ongoing decision to keep the church closed. The discussion took up a lot of time at every council meeting, and when the discussion was over the consensus was to remain closed. I am extremely proud that the Church Council has been unified in keeping our family safe. We have not had one Covid–19 case because we reopened. I do not know of any other church in Butte that can say that.

2020 has been a difficult year to put it mildly, but your Church Council has risen to a number of challenges, and I am honored to have served with all of them.

Outreach Ministry Team

Gold Hill Lutheran Church has and continues to have a solid base of outreach programs that continue to stay in motion because of the dedicated and diligent members of this congregation. These missions reach from within the walls to around the world. They include the Lutheran World Relief (LWR) Quilters group, the Prayer Shawl Knitters, Dresses for Africa, Hats and Scarfs, Stephen Ministry team, Sack Lunch Ministry, Nursing Home worship, Funeral lunches program, collecting for the Butte Emergency Food Bank, and supporting with leadership and labor, the Butte Furniture Bank.

This has been a tough year with the pandemic, but this family has found ways to continue to reach out. The quilters, staying aware of their health, quilted alone, quilted in the park, set up for pairs to quilt in a member's basement and even set up in the Butte Civic Center so that they could continuing their quilting ministry. Sack lunches were made in individual homes and dropped off or collected so they could be distributed to those in need. Prayer shawls, dresses, hats, and scarfs continue to be made and given or sent out. The Butte Emergency Bank could not take food donations but our faithful continue to remember those in need and donate money when possible. Hats, gloves, and those items needed for hygiene kits were donated and delivered to the Butte Rescue Mission.

The Butte Furniture Bank, which was started by members of Gold Hill in 2018, is now a community-wide outreach program which continues to be an immense help to newly housed people in Butte. A group of volunteers, most of them from Gold Hill, picked up, warehoused, and delivered furniture during most months of the year. The pandemic created challenges, but volunteers protected themselves for their own health and the health of those they came in contact with as they took in 797 pieces of furniture and delivered 702. They helped 84 families with beds to sleep in, tables and chairs so they could eat meals as a family, rockers to calm their babies, and living room furniture so that they might sit and relax with family and friends.

The Trust Committee Report

Thank you, Gold Hill members, for your generosity of gifts; memorial gifts, gifts to the Jennie Schotte Scholarship Fund and the Jeff DeWitt Bible Fund. We encourage you to consider both gifts and ministry ideas so that we may expand the benefits of the Trust Fund to Gold Hill and our community.

The Trust Committee manages three perpetual funds: the Jennie Schotte Scholarship Fund, the Jeff DeWitt Bible Fund, and the Graving Fund. The principle of each fund is retained, and the income may be used for designated purposes. In 2020 Memorial funds were directed as follows, based upon requests from congregational members:

- The Jennie Schotte Fund awarded a \$500 scholarship to Quinn Corbin, daughter of Julie and Gary Corbin.
- \$6268.63 was loaned to the church at an interest rate of 0.08% per year. Payments will start on January 15, 2021 and will finish on December 31, 2023.

Ron Gruss and Mike Welker were part of the Trust Review Committee, which met a few times and recommended that the Trust Committee should be dissolved. Interim Pastor Trina had recommended that the congregation should be presented with all the information. Then a vote of 2/3 of the congregational members would be needed to dissolve the Trust Committee.

Trust Review Committee Report

Ron Gruss, Chairperson

First and foremost, I would like to thank the members who served on this committee. They are Marshal Mickelson, Curt Quist, Mike Welker, and Bruce Graving. Throughout my career in corporate business, I realize the efficiencies gained whenever you consolidate administration functions. Because I also serve on the church auditing team, I also recognize the transparency you have when there is a separation of duties. Because of this I encourage all members to prayerfully consider The Trust Review Committee's recommendation listed in the minutes below.

Trust Review Committee Meeting of 1/27/2020

Attending: Ron Gruss, Marshal Mickelson, Curt Quist, Mike Welker, and Bruce Graving

The meeting is a continuation of discussions from 1/16/2020.

Marshal, following up on a question raised at that meeting, reported that after reviewing the Trust Resolution in detail in the context of Montana law, that Gold Hill had flexibility in how the Perpetual Funds were utilized so long as they remain as Perpetual or endowment funds.

Bruce pointed out that, based on a review of the last 20 years of Trust Committee reports, the Schotte Fund balance was about \$17000 in the year 2001 and scholarship grants were averaging about \$1500 to \$2000 per year. The Trust Committee, in discussions in 2007, recognized the balance couldn't support the program at that level for many more years. Accordingly, they moved about \$32,000 from undesignated memorial funds to the Schotte fund. Given that, the Trust Committee would appear to have the discretion to reallocate those funds if it so desired.

The conclusion at this point was that there was quite some latitude in how the Perpetual funds were used so long as their use remained consistent with the Trust Resolution requirements, primarily for ministries outside the general operations of the Congregation and consistent with the donors' wishes.

The discussion then centered on how best to administer both the Perpetual Funds and the Memorial funds in view of the shrinking demand for scholarships and Bibles for third grade children. Two questions, also discussed at the 1/16/2020 meeting, were the focus of those discussions: what options we have to simplify administration of the funds, and how should the funds be used in the absence of engagement from the Congregation as experienced for many years.

Marshal offered a motion that summarized the consensus developing from the Committee's discussions:

- 1. Transfer the Perpetual fund management to the Gold Hill Council who will designate an individual to act as a liaison with a financial institution selected by the Council to manage the investment of the Perpetual funds.
- 2. Transfer the Memorial funds to the existing Memorial Dedicated fund of the Congregation. The Congregation will be asked to approve a list of projects outside the general operations of Gold Hill to guide the use of those funds and to assist the Pastor when counseling families of deceased members desiring to make contributions to the Congregation.
- 3. Revoke the Trust Resolution, terminate the Trust and dissolve the Trust Committee since its responsibilities have been transferred to the Council and will be guided by a policy document to be written for that purpose. This reduces the need for elective positions by five and consolidates treasury functions in a single experienced person.
- 4. The earnings from the Perpetual Fund will be directed to ministries, including scholarships and Bible purchases, based on recommendations from the Outreach Ministry team and approved by the Council.

The motion was seconded by Curt and approved by the Trust Review Committee. The Trust Review Committee will request at the Council meeting of 2/11/2020 that the above be submitted to the Congregation at a special meeting, either for that purpose or in conjunction with the Call for a new Pastor.

ANNUAL REPORT FLATHEAD LUTHERAN BIBLE CAMP'S October 10, 2020 Annual Delegate Meeting

The 2020 Annual FLBC Delegates Meeting was held at FLBC Saturday, October 10th at 2 p.m. Due to the exploding Covid-19 infection rate in Flathead County, neither of Gold Hill's 2020 elected delegates attended Delegate meeting. This report is based upon a video of the Annual Delegate Meeting; the agenda, reports, and other materials distributed to the Delegates; and a telephonic discussion with FLBC Executive Director Margie Fiedler.

A theme of the Delegate Annual meeting was the grace-filled resilience shown by FLBC's staff and Board of Directors during an exceptionally challenging year. As the camp's leaders quickly learned, most of their advance planning for the 2020 camp season was mooted by the pandemic. FLBC Board President Sandy Drollman noted, "(w)e faced incredible challenges this spring and summer and continue to wrestle with what the ministry at FLBC will look like in the future."

When all factors are considered, FLBC has not only survived, it has actually grown in its ability to fulfill its Mission: "Living and proclaiming the Gospel in a time and place apart, we embrace Jesus' love, grown in faith, and leave renewed for Christian service." FLBC truly appreciates and is grateful for the awesome generosity of all who made and make it possible for it to continue its vital ministry.

While the annual reports of the FLBC Board President, Endowment Committee, Development Committee, and Executive Director as well as the Minutes from the 2019 Annual meeting, the 2020 Balance Sheet, and the 2020 P&L statement are all on file in Mary's office for review, four matters addressed during the Annual meeting are highlighted:

- (1) Many years ago, FLBC obtained a first-right-of-refusal for a piece of lakefront property on Hughes Bay bordering the camp's sailboat dock and extending inland to the camp's tent cabins and pavilion. Literally days before the Annual meeting, FLBC was notified of the pending sale and asked whether FLBC was interested in exercising its right of first refusal to acquire the land for the fair market price. FLBC Executive Director Margie Fiedler was able to pull together the requisite financing and Board of Director support. The option to buy was unanimously approved by the Board at its October 10th annual meeting.
- (2) The Great Divide Cluster's two members of the FLBC Board of Directors are: Bob Bentley (Gloria Dei) and Richard "Bing" Crosby, (St. John's Lutheran, Helena).
- (3) Retired Pr. Mike Borge, chair of the FLBC Endowment Committee, encouraged all to support FLBC's endowment fund "because the Endowment of FLBC will continue to support FLBC long after my earthly journey has ended." FLBC is grateful for the support the Lutheran congregations which own the camp [Gold Hill is one] provided the camp during 2020 -- a year like no other in the camp's storied history.

(4) While the camp's calendar year expenses through August 31 were lower, so, too, was the camp's income. For the first eight months of 2020, the camp has had a net P&L loss of \$122,774. However, the camp's 8/31/2020 balance sheet reflects a net equity increase of approximately \$250,000 over calendar year 2019.

The purchase of the lakefront property adjacent to FLBC's property is being paid for through special donations, a loan, and camp non-operating revenues. While gifts are still needed, a significant amount of money has been raised. Further, please note that FLBC is continuing its long-standing practice that no child will be denied attendance at camp due to an inability to pay.

Finally, if safe to do so, a team of FLBC counselors will be assisting Gloria Dei and Gold Hill with our joint 2021 VBS summer program.



- 2020 Summer Campers: 722; Fall/Winter/Spring Campers: 774 (in 2019, FLBC served 4,057 campers in the Summer, and 3,615 in the Fall/Winter/Spring)
- 19 incredible summer staff joined our 11 year-round staff to make 1 awesome ministry team
- Projected Annual Budget Shortfall: \$200,000

2020 at a glance:

 - Awesome retreats & events; Spiritual growth, faith, and fun

 - FLBC continues to offer year-round programmed retreats sponsored by camp, and host retreats brought in by groups with strict COVID-19 procedures
- October 2020: FLBC learned of a first right of refusal on a neighboring property on Hughes Bay! In God's timing, the FLBC Association voted unanimously at the October 10th Annual meeting to purchase the land for \$289,173 - generous gifts were received and \$125,000 was borrowed. On October 31, the land was officially a part of camp! Thanks be to God!

Dear Siblings in Christ,

The season of Epiphany – the revelation of God's light into the world – has come. And with it also come annual meetings for you in your congregations.

It's been a wild and crazy year, hasn't it? Last year at this time, we were meeting in person, preparing budgets, voting for new council members and getting ready for the new year; yet we were still in the dark about what was heading our way. Now a year later, Covid-19 hasn't disappeared as we wished; things haven't gone back to normal. Instead, hundreds of thousands have died, we're exhausted, and we're still disagreeing about masks.

But there is also a light dawning on the horizon. Vaccines have been developed through the God-given talents of doctors and scientists and, if all goes well, we will be able to gather again for worship, faith formation, fellowship and service sometime this summer if not sconer.

Over the past year, we as your synod staff have been honored to travel with you and your congregation on this difficult journey. While we weren't able to "fix" things or make it all go away, we hope that the guidance, support, resources, encouragement, and love helped you to do the work of the gospel in the dark days as well as the bright ones. We too have been exhausted by the realities we as a church were facing, but it was and continues to be a joy to equip you in the ministry Christ has called you to in your community.

"Synod" means "walking together on the way." And in spite of everything that has happened, all of us — whether congregations or ministries, synod staff or synod council, WELCA or ecumenical friends, members or affiliates — we in the Montana Synod have walked on the Way of Jesus Christ together this past year, equipping one another to do things we hadn't thought possible before the pandemic. Even though it was hard to see sometimes, the light of Christ was there calling us forward into the ministry of the gospel and we followed it in beautiful ways. Thank you for all you have been doing to share God's love during these difficult days!

But we're not to the end of the tunnel yet. We may be able to see the light, but we still have some distance to go. Events and activities will continue to be affected over the next months by our need to love and protect one another from the virus. This includes the Synod Assembly, which for the first time ever will go virtual. Though it will still be held during the first weekend in June, it will look and feel much different than past years. Thankfully, we will not be the first to conduct our assembly digitally. This past fall, several synods held their assemblies online, including having bishops' elections. If they can do it, so can we!

More detailed information about the 2021 MT Synod Assembly will be coming in January about what your delegates will need to do to prepare. But one thing you can do at your annual meeting is to find and elect delegates who have some comfortability with the technology of computers or people who are willing to learn. While this may seem rather daunting right now (I know I'm feeling the pressure of leading my very first assembly online), by June we'll be as ready as we can be to let the Spirit guide us into the new possibilities this digital assembly will open for us now and into the future.

No, we're not where we want to be yet. But that's okay. We can make it. Treasurer's Report

As we all know, 2020 was a challenging year for everyone. Gold Hill Lutheran Church did not escape the challenges of 2020 and the pandemic. An additional challenge that faced our church was the need to replace the roof of our entire building. We did not have funds planned for such a costly need.

We had approved an aggressive budget in terms of income planned. With our budget surplus from 2019 we had planned a net income loss of \$10,950. But with the pandemic we did not meet our planned income. Our income was \$17,843.43 less than budget. But again, with the pandemic, some of our planned and budgeted programs did not occur which resulted in less expenses than planned. A change in our pastor (twice) netted some savings also. **Gold Hill ended 2020 with a net income loss of \$3,817.78.**

We were able to send 10% of our envelope and loose offering to the Montana Synod. The roof replacement was partially paid for with insurance proceeds and contributions from the congregation. We needed additional funds to cover the cost of the roof. The Trust Committee agreed to loan the church \$6,268.63. The loan has an interest rate of .08%. The loan period is 3 years. Monthly payments will be \$176.28.

The 2021 budget has income budgeted less than 2020. The budgeted income is close to what was actually received in 2020. We are hopeful that income will be higher than planned once things in the world get back to something close to what normal was for us. Expenses are less that were budgeted in 2020. We are planning a net income loss of \$282.00.

Thank you to the Council for their patience and understanding and input while we discussed the financial condition of the church and planned for 2021. Thank you to the entire congregation for being so faithful in your giving during this time of challenges. Together we can brave and survive the storm. I believe that there are better days ahead. I am grateful for our church and congregation and all that we do.
