# From the Pastor's Study

Friends in Christ,

As some of you have heard it is being discussed at the Council level to cut my time and Mary's time to 30 hours a week due to our Congregation's financial need for the year of 2022. **First and foremost: Mary and I fully support this plan!** You need to know that. Both of us feel that this plan is fully in the best interest of the Congregation and the greater community of Butte. It is a way for us to act as Stewards of our time and talent for the glory of God. And I can tell you that part of my job is to assess this congregation and enter into hard conversations like this one when we have a choice rather than before we are forced to make hard decisions. We are asking for 1 year of breathing room in our budget so we can fully assess who and what we are as a called body of Christ.

Now, I recognize that this may come as a shock to some of you, but here is the reality that we are in. We did not meet our budget last year, in fact we needed to drop our budget about \$25,000 this year, from about 175K to 150K. The initial way this was accomplished was through looking inward. We chose to not give to the Synod or any other outside ministry. This is simply not a good stewardship model for our congregation. **God calls us to look outward and to give outward, especially in terms of our time, talent, and money**. Frankly, Mary and I are your largest expenses, but both of us have noticed through Covid that the needs of the congregation have simply changed from when I was called here in 2020. We are both only needed about 30 hours a week and we feel guilty being paid at a full-time benefit when we are not working full time. This change would alleviate that guilt.

Second, it becomes a justice issue. Over the last 10 years our Average Weekly Attendance has fallen from 133 to 38, but our budget has only risen over that time. At our new budget of 150K if we still had 133 people here, we would be asking each person to give about \$1000 over the year (or about \$20 a week) to the church. But now we are asking thirty-eight people to give \$3950 a year (or about \$80 a week). **And note these numbers are per person!** not per family. That means a couple is asked to give \$8000, my family of four would need to give \$16000! a year to the church and many of our parishioners simply cannot do that. This reminds me of the widow's mite. It is not fair for us to ask those on fixed incomes or salaries to simply tighten our belts and give 'til it hurts and forego a meal so that the church remains solvent.

So, what are we asking? We are asking that we all take a step back and recognize that we are in a lean time. We will have faith that next year will be better, but right now we, as a congregation, need to be able to take a step back, take a deep breath, and look at our congregational needs and assess a way forward that is fair and equitable for all of God's people.

Finally, from a logistical end, what does ¾ time mean for this congregation? It means that the office will still be covered each day from 8am – 12pm and 1pm – 3pm. It means that your pastor will have two days off a week to be involved in other ministries in Butte (Hospice, BRM, Homeless Care, Prisoner Integration, etc.). Your pastor will still be here for you. Funerals, worship, hospital visits, and weddings will still be conducted, and the glory of Christ will still shine through this Congregation.

And what does ¾ time not mean? As of right now, it will not be forever. We are asking for a breathing year to reassess our needs and our ministry without the cloud of "not bringing in enough money" looming over our head.

This plan would be reassessed next year at our annual meeting. At that time, maybe we laugh off our "over abundance," or perhaps we all breathe a sigh of relief that we made this hard choice now and turned our view outward to continue giving to the community the best we can. Again, I would just like to remind you that Mary and I are fully in support of this plan and feel that it is a gift, an act of stewardship, of our time and talents this year.

#### Council Meeting Minutes – Gold Hill Lutheran Church Tuesday, January 11, 2022

The meeting was called to order at 6:00 p.m. by President Mike Lawson. Roll was taken. Mike Lawson, Curt Quist, Danette Fitzpatrick, Peggy Graving, Nicholas Conlan, Pat Gruss, Chris



Ketchum, and Pastor Carrels were present. Lynn Aniksdal was excused.

Devotions were given by Pastor from 1<sup>st</sup> Corinthians the 12<sup>th</sup> chapter. We are one body with Christ. Though each of us is a part we each have amazing gifts we bring to the community of Gold Hill and this council. God values each of us as we serve on this council. He thanked those who would be leaving the council after completing their terms.

Curt Quist moved, and Danette seconded that the minutes for the December 2021 meeting, previously emailed, be approved as sent. The motion carried.

Danette presented the treasurer's report. December was below the expectations we had. We expressed our concerns for the low income and the lower than projected year. We will discuss further under the budget in Old Business. The motion was made by Peggy and seconded by Chris to accept the treasurer's report.

Pastor's report was emailed and is attached (*p. 7*). He added that he has been asked to preside over a wedding that the couple would like to hold in our social hall on February 22, 2022. The couple is not affiliated with the church. After discussion it was agreed that we follow the policy in place for non-members and charge the \$150.00 fee. We will clean the best we can not knowing where Dayspring will be in the reconstruction process.

Mike reported that he and Annette have had Covid and explained the process for testing that they have gone through. Their cases were light. He will get with Dayspring this coming week and walk through the church.

Curt reported that the progress at the church has been slower this month. Electricians and plumbers are not as far along as hoped. The flooring on the main floor in the offices and upstairs should be completed within the next couple of weeks. Pastor and Mary can move back into the church hopefully by the beginning of February. Curt has offered to remain the liaison between the council and Dayspring though he is going off the council. The council agreed that it would be wise and appreciated his willingness to remain the liaison. Curt has been working with Jennifer, the project manager for Dayspring, regarding the installation of the security system that we previously had. The pianos were due to be moved and Curt has asked that they remain where they are until we are ready for all of them. We discussed the organ regarding whether we wanted it back in the sanctuary. It was state of the art for its time but is no longer state of the

art and it was discussed whether we wanted it moved back into the sanctuary or not. We decided this was a decision for the congregation. We will bring it up for discussion at the annual meeting.

Chris reported that the worship committee met and has emailed their minutes to the council. They are discussing the Lenten Wednesday night services and are undecided, with the outbreak of the Covid Omicron variant, whether they will have soup and bread or not. They want to make their decision early enough to add the Lenten announcement to the February Nugget. We are going to have the service with masks, social distancing, sharing the peace by sign, plastic individual communion cups, and no coffee hour for now. Sue Repola is willing to play the piano once a month for Dave. They will work out which Sunday she will play. Lynn Aniksdal had nothing to report. Lynn and Lynn Heinze will schedule the biannual walk through of the parsonage this month.

Pat reported that she understood the church did not have the funds (\$2600) at this time to have FLBC VBS. She is willing to take on the VBS herself. She will inform Gloria Dei of our decision.

Nicholas had no report. He will meet with Pastor regarding the Google for Nonprofits before the next meeting.

**New Business:** There was no new business.

Old Business:

Pastor read the report from Revonda Stordahl and the nominating committee. There is still no nominee for the secretary's position. People who would be willing to serve will be asked to volunteer to place their names in nomination at the meeting. The slate of nominees are as follows:

Nominating Committee was not selected yet. The possibility of not being able to hold the annual meeting in person was discussed. Possibilities will be reviewed for zoom with voting availability. It limits us because we have members who do not have this access. If we have no nominee for secretary Pastor said we could not follow the constitution and proceed without a secretary. The constitution says a secretary remains secretary until another one is elected by the congregation.

Arlene Munyon would like to send out birthday cards. There is no objection, but we do not have the funds to pay for the cards and postage. Pat Gruss volunteered to pay for the cards and the postage if needed.

Budget – The proposed budget was presented to the council. After much discussion regarding the low numbers for mission and outreach and no funds being sent to the synod it was decided that we needed to look at alternatives, such as

visiting with Pastor and Mary regarding working 2/3 or 3/4 time. Pastor was open to these discussions. Curt and Danette will visit with them and get back to the council. At this time, we had a motion by Curt that we accept the proposed budget as is. The motion was seconded by Nicholas and passed. Agenda for the Annual Meeting – We discussed the following items needed to be placed on the agenda for the annual meeting: Update on the reconstruction of the church; the organ; a constitutional review committee be created to review the new synod recommendations and requirements after their June meeting to make needed changes to our constitution to be in compliance with the synod; and the motion brought to the floor at the previous annual meeting regarding accepting the recommendation of the Trust Review Committee.

Curt presented his final Team Building thought on the need to have openness and vulnerability. It is powerful to listen to others and to be able to admit when you are wrong. People respect you more when they know you realize that you make mistakes and own up to them. It is important to apologize. Tell someone you are sorry. It is a healing process. This is important if you want to have others Trust you and for you to be able to Trust others.

The meeting was closed with the Lord's Prayer.
