Message from Presiding Bishop Eaton

Bishop Eaton issues message on 80th anniversary of Pearl Harbor Day

"Every valley shall be lifted up, and every mountain and hill be made low; the uneven ground shall become level, and the rough places a plain" (Isaiah 40:4).

Eighty years ago, on a beautiful Sunday morning, Pearl Harbor, Hawaii, was tragically transformed from an island paradise into a bloody battlefield. After the Japanese bombed the U.S. Navy, war was declared, and tragedy ensued. During times like these, the Lutheran church has always trusted our chaplains to bring a ministry of Word and Sacrament — to remind people that, no matter how difficult the circumstances, there is always a way toward peace. Amid tragedy, destruction, and death, those who follow Jesus are still called to hope.

As we continue to live with the impact of COVID-19, did any of us think that this pandemic would be so protracted? We had no way to know about Delta or Omicron variants. We have seen rises in anxiety, incivility, anti-Asian violence and the harmful theology of Christian nationalists and other extremist groups, the same kind of sentiment that led us to intern Asian Americans after the bombing of Pearl Harbor in 1941. We must do better than that. As we are reminded by the light from our Advent wreathes, we are called to illuminate and enlighten.

The advent of our Lord Jesus is the event that turns all human history on its head. We follow Jesus rather than the warmongering, death-dealing principalities, and powers of this world. Like our ELCA federal chaplains, like the prophet Isaiah, we are called to promote a different way — a way of justice, of equity, of healing and recovery. We are ambassadors of Jesus, the Prince of Peace, who enters our world to bring peace, healing, and hope.

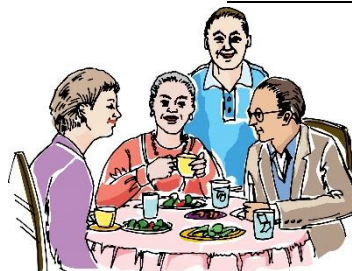
Sunday School has started up again at Gold Hill! We are meeting after the 9:30 service.

Old Business

- Ron Gruss opened the meeting

 - 2) The roof fund loan is now paid down to \$2301.98 with the next payment due on 1/15/2022.

- Discussion was held as to what needs to be included in the annual report. Ed and Ron will be doing the financial part of the report.

Council Meeting Minutes – Gold Hill Lutheran Church Tuesday, December 14, 2021



The meeting was called to order by President Mike Lawson. All members of the council were present: Mike Lawson, Curt Quist, Danette Fitzpatrick, Peggy Graving, Pat Gruss, Lynn Aniksdal, Chris Ketchum, Nicholas Conlan, and Pastor Carrels.

Devotions were from Luke 1 – Verses 1-6. Pastor said sometimes, we get bogged down in the details. We don't always need to know who did what, where, etc. We need to get the whole picture. The Gospel has eyewitnesses that tell us the story. We, as a council, need to know what to take to the congregation – what message do we give.

Minutes: The minutes from the November meeting were reviewed. Curt moved; Lynn seconded the acceptance of the minutes. The motion passed.

Treasurer's Report: Danette emailed the financials to the council prior to the meeting. Danette reported that the income for November was \$10,617.70. Expenses for November were \$17,744.35. The deficit for the month is \$7,126.65. Year to date we are \$10,767.50 behind. Nicholas moved we accept the report. It was seconded and passed.

Pastor's Report is attached (p. 7-10). He will be on vacation from December 27 through January 2. He also attached the Covid report from the county.

President's Report: Mike reported that our attendance for services is between the high thirties and the low forties. The office areas in the church are getting textured and then they will be painted. The upstairs is getting painted and will be ready for new flooring. The basement is getting its lowered ceiling. The ramp going into the Sanctuary is ready for texturing and then painting. The process is moving forward. He thanked everyone for their reports.

Administrative Director's Report: Curt reported the same updates that Mike reported above. He added that the electrical work is complete except for a few fixtures. Pastor and Mary are deciding which bookcases and storage cabinets they want back in their offices. Flooring is scheduled for the beginning of the new year. Rande Farrow has completed the new arch for the sanctuary, and it will be installed after the new wall behind the sanctuary is built and the electricians are done.

Dayspring has started the restoration before they have received any payment from the insurance company. An invoice has been submitted but no funds have been received. They are using the mitigation money to continue working. Curt also signed a change order last week for the installation of the handicapped bathrooms that has been sent to the adjuster. Curt tried to connect with Julie Corbin and Heatherlynn Meeks about changes needed to our website and has received no response. He would like council to authorize

Pastor to make updates. Nicholas and Pastor will work on getting this done and looking at Google nonprofit for our church.

Worship Committee: Chris submitted a report via email. Her committee is ready for the Christmas services but wanted input on how we would admit people if we have more turn out than space. We will open up the doorways to the fireside and hallway and put a few chairs there. The occupancy for the services would be between 50-70 depending on family units. The choir asked if they could begin meeting in the social hall for practice. This request was granted. Because our service has increased to over 40 and our chairs are in random order around the social hall, we will have ushers directing people to communion. There has been a request to sing Lamb of God and to sing during the offering.

Property Committee: Lynn Heinze and her husband will be shoveling the sidewalks, so no volunteers are needed.

Spiritual Committee: Pat thanked Danette for paying for the VBS program. We discussed how many children we are serving and the price of the FLBC counselors. Last year for \$1,000 we had either zero or one camper. We may need to look into an alternative. The Presbyterian Church would like to visit with Pat about the VBS program and may be interested in joining Gloria Dei and Gold Hill for the camp.

Outreach Committee: Nicholas is eager to have our kitchen and social hall completed. He has ideas such as a cooking class and a soup kitchen. Pastor asked him to meet with the task force to see about what outreach ideas would impact the construction project. When Nicholas meets with Pastor regarding the website, they will look at Google for Nonprofits and see if it is a match for our church.

New Business: The Annual Meeting will be February 6th without a potluck. Every three years when the Church Wide Assembly updates the constitution churches should follow through and update their constitutions with the changes necessary to keep us compliant with church wide. At the annual meeting we will be asking for 4 people interested in reviewing and making the necessary updates when the Assembly's changes are out. This should happen after June of 2022.

Old Business: Pro-Audio sent us another proposal for a scaled down audio/visual update for the church. The bid came in at \$31,177.42. After much discussion it was decided we could not spend this kind of money on our own. It was asked that we bring up the topic at the annual meeting for members to be able to have input. We are in the process of figuring out where we stand with the money given by the insurance company and the work that Dayspring has completed. Once we know where we stand and understand how much money we, Gold Hill, will need to have to complete the projects already agreed upon we can further discuss the audio – tech money available.

Rande Farrow submitted a report to Curt. He reported that

council had approved the arches for the sanctuary. The committee went to the Furniture Bank and selected furniture for the quilters room, the fireside room, and a desk for one of the upstairs rooms. No other decisions have been made at this time.

Budget – Every committee member needs to get their budget requests to Danette. Danette will have a budget prepared for our approval at the January council meeting.

Goals for the Church from the Guiding Principles will be discussed in January.

County Covid Update – The county is 100% open. It is up to businesses to create their own policies regarding distancing and masks. After discussion we decided to remain wearing the masks and distancing during services. Since we have offered the sharing of the peace, we will continue with everyone using their own discretion. Lynn moved; Chris seconded to keep the above practice for church services. The motion passed with Nicholas opposing.

Curt continued our discussion regarding everyone working together. Tonight's topic was Fairness. We need to listen to each other even if we don't agree and give the person your full attention. Make it a point to try to see where that person is coming from and how he builds his point of view. Curt asked us to continue to pray for the person we have been for the past few months.

Pastor thanked us for facing the hard decisions. We have the heart of the congregation in our thoughts and prayers.

We adjourned with the Lord's Prayer.

COVID-19 in Silver Bow County

Butte-Silver Bow Health has activated its emergency response team and is working daily to prepare for the likelihood that COVID-19 will spread to Butte-Silver Bow County. We are also working closely with local health-care providers to monitor for the disease. COVID-19 is a respiratory disease that originated in China in late 2019 and has since spread throughout the world. The disease can have mild to severe symptoms, including fever, cough, and trouble breathing. It can also be fatal, especially in the elderly and people with existing health problems. What You Can Do to Avoid COVID-19 – Assess Travel Risks

The best thing you can do to avoid the disease is to avoid exposure to the virus that causes it. In part, this means avoiding travel to areas where the virus is epidemic. The Centers for Disease Control (CDC) issues advisories for travelers regarding potential exposure to disease in other countries. These travel alerts are likely to change as the disease spreads. COVID-19 Information for Travelers (CDC) – Practice Good Personal Hygiene

Everyday precautions that can help prevent the spread of flu and other germs are also effective against the virus that causes COVID-19.

- Wash your hands often with soap and water for at least 20 seconds, especially after using the bathroom, before eating, and after blowing your nose, coughing, or sneezing;
- If soap and water aren't available, use a hand sanitizer containing 60 percent alcohol;
- Avoid close contact with people who are sick;
- Avoid touching your eyes, nose, and mouth;
- Stay home when you're sick;
- Cover your coughs and sneezes with a tissue, and then throw the tissue in the trash; and
- Clean and disinfect surfaces and objects that may be contaminated.

Recommendation Regarding the Use of Cloth Face Coverings, Especially in Areas of Significant Community-Based Transmission

CDC continues to study the spread and effects of the novel coronavirus across the United States. We now know from [recent studies](#) that a significant portion of individuals with coronavirus lack symptoms (“asymptomatic”) and that even those who eventually develop symptoms (“pre-symptomatic”) can transmit the virus to others before showing symptoms. This means that the virus can spread between people interacting in close proximity—for example, speaking, coughing, or sneezing—even if those people are not exhibiting symptoms. In light of this new evidence, CDC recommends wearing cloth face coverings in public settings where other social distancing measures are difficult to maintain (e.g., grocery stores and pharmacies) especially in areas of significant community-based transmission. It is critical to emphasize that maintaining 6-foot social distancing remains important to slowing the spread of the virus. CDC is additionally advising the use of simple cloth face coverings to slow the spread of the virus and help people who may have the virus and do not know it from transmitting it to others. Cloth face coverings fashioned from household items or made at home from common materials at low cost can be used as an additional, voluntary public health measure. The cloth face coverings recommended are not surgical masks or N-95 respirators. Those are critical supplies that must continue to be reserved for healthcare workers and other medical first responders, as recommended by current CDC guidance. If You Think You Have COVID-19 – Call If You're Sick

Symptoms of COVID-19 include a fever, cough, and difficulty breathing. If you have symptoms -- and if you've been in close contact with someone who has the disease or have traveled to an area with ongoing spread -- call your health-care provider before visiting. Tell your provider about your recent travel or contact.

Your provider will make sure you don't expose others in the office or hospital setting. He or she will also work with public health professionals to determine if you need to be tested.
